CONFIDENTIAL DISCLOSURE AGREEMENT

Between RedShift Ltd, Wellington, New Zealand (hereinafter "The Discloser"). AND:

(hereinafter "The Recipient")

WHEREAS

The Discloser is establishing a franchised network of web retail outlets throughout New Zealand according to a method developed by itself and is the owner of "confidential information" relating to the establishment and operation of businesses specialising in the web industry.

AND WHEREAS

The Recipient is interested in becoming a franchisee of Nettl and for this purpose wishes to evaluate The Confidential Information.

NOW THEREFORE

In consideration of the premises and the covenants herein contained, The Discloser and The Recipient agree;

1. The Discloser will supply The Recipient with information on the operations of Nettl which in the view of The Discloser is sufficient to enable The Recipient to make an informed decision on entering into a franchise arrangement.
2. "The Confidential Information" shall include any and all information or materials disclosed or passed to The Recipient by The Discloser relating to the franchise with the exception of:
 - (i) information which as at the date of receipt by The Recipient was in the public domain, or subsequently entered the public domain without fault on the part of The Recipient;
 - (ii) information that at the time of receipt by The Recipient was known to The Recipient.

3. The Recipient recognises the confidential nature of The Confidential Information and agrees that the Confidential Information shall only be disclosed to the officers of The Recipient authorised by the discloser.
4. The Recipient shall hold The Confidential Information in confidence and shall not disclose or permit The Confidential Information to be disclosed to third parties or employees not authorised without the express authority of The Discloser.
5. The Recipient will take all reasonable precautions to maintain the secrecy and prevent disclosure of The Confidential Information.
6. The Confidential Information will be used solely for the purpose of evaluating the proposed franchise opportunity and if The Recipient and The Discloser do not reach a mutually acceptable agreement The Recipient agrees not to use The Confidential Information for its benefit or to the benefit of a similar proposal in respect of a print retail business.
7. The Recipient agrees to, at The Discloser's request, return or destroy all of the Confidential Information supplied to The Recipient under this agreement.
8. The obligations of confidentiality undertaken herein shall survive the termination of this agreement, and the obligations of the officers listed in schedule 1 and shall survive the termination of an officers' employment with The Recipient or the termination of this agreement.
